# I. MOTION

MOVE TO EXTEND A 3-YEAR CONTRACT WITH REGIONAL FINANCIAL ADVISORS, ALSO KNOWN AS SEATTLE-NORTHWEST SECURITIES, FOR ONE ADDITIONAL YEAR, EXPIRING DECEMBER 31, 2010 AT NO ADDITIONAL CONTRACT DOLLAR VALUE.

# II. DISCUSSION

## A. Background / Analysis

Regional Financial Advisors (RFA), now merged with Seattle-Northwest Securities (SNW) as of 2007, is a top ranked financial advisory firm in Oregon, and Lane County has been under contract with them since 2002. The contract expired 12/31/2009.

SNW was our financial advisor for the 2009 bonds we issued November 2, 2009. The 2009 bonds were originally drafted to include improvements to the Community Health Center in Springfield, but when it was determined an American Recovery and Reinvestment Act (ARRA) grant was submitted for the same improvements, the County was compelled to stop the bonding process for those costs in the event the grant was awarded. To do otherwise would have been illegal. In mid-

December of 2009, the County received notice that the grant would not be awarded to the County. Therefore, the County will seek to bond those costs as early as possible in 2010.

A 1-year renewal of the contract would allow the County to effect the sale of the 2010 bonds as soon as possible. SNW already has many of the legal components in place to affect such bonds and it would be in the best interest of Lane County to proceed with this sale as early as feasible. The necessary delay required to perform an RFP for financial advisory services could be detrimental to the County if interest rates start to increase.

The original contract resulted from a formal bid and was approved by the Board. The amount of the contract does not increase and the scope of work remains unchanged. If the contract extension is approved, Lane County will prepare an RFP for financial advisory services when the 2010 bonds have been sold.

# B. Recommendation

The Finance department recommends that the Board approve the motion to extend the current contract with Seattle Northwest Securities, also known as Regional Financial Advisors, one additional year to December 31, 2010 and that the County Administrator be authorized to execute the amendment.
