II. <u>DISCUSSION</u>

A. <u>Baekground/Analysis</u>

Lane County Sheriff's Office (LCSO) submitted a Title II Project Application to the Bureau of Land Management (BLM) Resource Advisory Committee on 31 July 2009 requesting funding in the amount of \$252,456 for the Adult Inmate Work Crew program during FY10.

The funding was approved and during June 2010, BLM requested an online application be submitted in order to receive the Cooperative Agreement.

The IWC has been working and invoicing under the FY08 Cooperative Agreement through the FY10 Third Quarter when the funds ran out.

BLM requested the required forms be submitted through their online system as soon as possible in order to award the FY10 funds and provide a new Cooperative Agreement.

Board approval is required for amounts over \$100,000, and both the application and Cooperative Agreement are for \$252,456.

B. <u>RECOMMENDATION</u>

Staff recommends approving ratifying the application submission to BLM for FY10 Title II funds in the amount of \$252,456 for the IWC and authorizing execution by the County Administrator the FY10 Cooperative Agreement.

The IWC budget, staffing and crews are based on receiving the FY10 BLM Title II funds this fiscal year.
