II. **DISCUSSION**

Background/Analysis A.

Lane County Sheriff's Office (LCSO) applied for and was awarded FY09 Title II funding from the Hood/Willamette, Siuslaw and Rogue/Umpqua National Forests to provide funding for the Adult Inmate Work Crew (IWC).

The Sheriff's Office IWC was awarded \$134,247 from the Hood/Willamette Resource Advisory Committee (RAC), \$74,022 from the Siuslaw RAC, and \$30,391 from the Rogue/Umpqua RAC.

During May 2010 the US Forest Service emailed the award packages and requested Modification Number 2 to the Cooperative Agreement be signed by the County Administrator, and mailed back to them for signature by the Forest Supervisor.

It was necessary to have the County Administrator sign the modification without delay since the review process and signature by the Forest Service would take

several weeks to complete, and the IWC has been working the Forest Service projects since the beginning of FY10.

Board approval is required for awards over \$100,000, and the Cooperative Agreement Modification Number 2 is in the amount of \$238,660.

B. RECOMMENDATION

Staff recommends approving ratifying execution of Modification Number 2 to US Forest Service Cooperative Agreement 08-CA-I 1061800-027 by the County Administrator.

The IWC budget, staffing and crews are based on receiving the FY09 funds this fiscal year.
