City of Dunes City

Measure No: 20-352

Caption: Measure proposing an amendment to the Dunes City Charter.

- Question: Shall the Dunes City Charter be amended to provide that City public contracts are governed by state law?
- Summary: The City Council recommended this measure after review of Oregon public contracting laws and the City Charter.

Currently, Section 39 of the City Charter requires a public contracting process for public improvements that is stricter than state law and does not allow the City to take full advantage of modern contracting processes.

If adopted, this measure would require the City to follow Oregon law for its public improvements contracts. The Charter amendment would allow the City the advantage of certain public contracting processes that are governed by state law but not contemplated by the current City Charter.

The measure would amend City Charter Section 39 to read: "Contracts for public improvements shall be governed by state public contracting law."

#### City of Eugene

Measure No: 20-349

Caption: Amends Charter, changes method for electing mayor and city councilors.

- Question: Shall Charter be amended to eliminate primary elections for mayor and councilors and elect them using the STAR Voting method?
- Summary: This Charter amendment replaces the current method of electing mayor and councilors with the STAR Voting method.

Currently, all mayoral and councilor candidates are voted on in a May primary election; if a candidate receives more than 50% of the votes, the candidate runs unopposed in the November general election. If no candidate receives more than 50% of the votes, the top two candidates run against each other in November general election.

This Charter amendment adopts the STAR Voting method, an election process where: 1) all candidates are voted on at November general or special election; 2) voters score each candidate on a scale of zero to five, multiple candidates can have same score (no score equals zero); 3) scores are totaled for each candidate; 4) "finalists" are the two candidates with highest total scores; 5) finalist preferred by the most voters is elected to office.

This amendment requires City to include information about the STAR Voting method on the ballot and Council to adopt an ordinance to administer elections using STAR Voting.

#### City of Eugene

Measure No: 20-358

Caption: Bonds Funding Lane County Multiuse Stadium at Fairgrounds

- Question: Shall Eugene contribute funds towards the Lane County multiuse stadium at the fairgrounds using \$15 million of general obligation bonds? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.
- Summary: If approved, proceeds from the sale of the bonds will be used for capital costs related to construction of the Lane County multiuse stadium at the Lane County Fairgrounds. If approved, proceeds from bonds' sale will fund a portion of the stadium's total capital costs, estimated at \$90 million. Based on Lane County's conceptual stadium design, a multiuse stadium at the Lane County Fairgrounds will function as the Eugene Emeralds' home baseball stadium and could be programmed for music events, sporting events, and other community events. If constructed Lane County will own the multiuse stadium and lease it to the Emeralds. If approved but construction on the multiuse stadium does not commence at the fairgrounds, the bonds will not be sold, no bond proceeds will be generated, and no money will be provided to Lane County.

If approved, the estimated rate is \$0.08 per \$1000 of assessed value per year for 20 years, cost to average Eugene homeowner would be about \$22 per year. Bonds would be limited to principal amount of \$15 million.

Measure No: 20-351

Caption: Authorizes general obligation bonds to fix streets.

- Question: Shall City of Springfield issue \$20,000,000 in principal amount of general obligation bonds to fix deteriorating streets? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.
- Summary: If this measure is approved, City will use bond proceeds to fix streets. Bond proceeds will only be used to fix existing streets and pay bond issuance costs. The City expects to fix the streets listed below with bond proceeds. See Springfield Resolution 2024-05 for a full list of streets that could be fixed using bond proceeds if funds are available.

Harlow Road: I-5 to Pioneer Parkway/MLK Jr. Parkway roundabout

Aspen Street: Menlo Loop to Centennial Boulevard

'G' Street: 10th Street to 23rd Street

36th Street: Main Street to Commercial Avenue

Daisy Street: South 51st Place to Bob Straub Parkway

58th Street: Main Street to Thurston Road

The City will publish periodic reports to document completed bond projects.

The City expects to levy taxes for five years to repay the Bonds. The estimated rate is \$0.74 per \$1000 of assessed value, or about \$135 per year (\$11.25 per month) for the average Springfield homeowner.

Eugene School District #4J

Measure No: 20-357

Caption: Renewal of current five-year local option tax for general operations

- Question: Shall Eugene School District continue to levy \$1.50 per \$1,000 assessed value for general operations for five years beginning FY2025-26? This measure renews current local option taxes.
- Summary: Since 2000, voters have approved a local option levy at the rate of \$1.50 per \$1,000 of assessed valuation to support Eugene School District 4J operations. This measure renews this levy at the same rate.

The current voter-approved levy provides funding for retaining teachers and delivering instructional programs which students need for a well-rounded education.

If approved, this measure provides funds to maintain current school programs and staffing levels. If not approved, without continuation of the revenue, in 2025-2026 the district will need to reduce its budget by approximately \$26,400,000. The estimated impact is the equivalent of cutting about 200 teachers or 32 school days.

The local option levy renewal is projected to raise a total \$91,900,000 over five years:

2025-26: \$26,400,000 2026-27: \$27,300,000 2027-28: \$28,100,000 2028-29: \$29,000,000 2029-30: \$29,900,000

This measure continues the current tax for the local option levy. The annual rate will not exceed \$1.50 per \$1,000 of assessed value for any property; rates for some properties will be less.

If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

Summary: District proposes to issue \$16,115,000 in bonds and receive \$6,000,000 state grant only if bonds are approved. Funds would finance capital costs, including: Elmira HS:

- o Update HVAC system and instructional spaces
- o Construct new multi-use turf field, track, athletic complex
- o Repair and replace doors, parking lot, driveways
- Fern Ridge MS:
  - o Update HVAC system, instructional spaces, outdoor space
  - o Improve traffic flow by repairing and replacing parking lot and driveway
- Elmira ES:
  - o Provide security fencing
  - o Improve drainage
  - o Expand play area, add walking track
- Veneta ES:
  - o Upgrade gymnasium
  - o Replace and expand parking
  - o Improve drainage
- · Add and improve sports fields
- · Update and repair restrooms
- · Site improvements, demolition, furnishings, equipment, interest, bond issuance costs.

Citizen oversight committee.

Bonds may be issued in multiple series; maturing within 16 years from issuance. Estimated overall combined bond annual tax rate would be \$2.20 per \$1,000 of assessed value. Actual levy rates may differ due to final interest rates and changes in assessed value.

Measure No: 20-355

Caption: Bonds to improve safety, learning; update schools and athletic facilities

- Question: Shall Junction City School District No. 69 improve schools; issue \$59,070,000 in principal amount of bonds? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.
- Summary: If voters approve this measure, the District will receive a State grant of \$3.9 million and may receive an additional grant of \$2.1 million.

If approved this measure would finance capital costs, expected to include:

- safety and security improvements;
- expanding capacity at schools including with a new cafeteria and gym at Laurel Elementary School;
- additional classrooms and removal of modular classrooms;
- providing upgrades and improvements to facilities, including replacing roofs and modernizing HVAC systems;
- providing new athletic fields and a Grandstand Building;
- · renovating media center at Oaklea Middle School;
- play structures; and
- bond issuance costs.

The District would establish a citizen oversight committee to ensure proceeds are used for purposes indicated.

Bonds may be issued in multiple series; each maturing within 21 years from issuance.

District's bond tax rate is expected to increase from current rate of \$1.48/\$1,000 of assessed value to an estimated total District bond tax rate of \$2.69/\$1,000 of assessed value if measure passes. Actual levy rates will change based on final interest rates and changes in assessed value.

#### McKenzie Fire & Rescue

Measure No: 20-356

Caption: Replace Current 5-year Operation Levy.

Question: Shall the District Replace a 5-year Operation Levy at 1.05 per \$1,000 of assessed value beginning in 2025 -2026?

This measure may cause property taxes to increase more than three percent.

Summary: This measure is a renewal with added tax. It is a 5-year Operation Levy that replaces the current levy passed by voters in 2018 that expires in 2025.

The tax revenue from this measure will allow McKenzie Fire/Rescue to continue to operate at its present level of fire protection and emergency medical services. Examples include continuing the day-to-day operations of the District, providing training to volunteers and staff, and maintaining District facilities, and equipment. Most importantly, this measure allows the District to maintain current staffing levels of nine (9) full-time employees, three (3) part-time summer positions, and the Student Program.

The proposed rate of \$1.05 per \$1,000 will raise approximately \$922,845 in 2025-2026; \$950,530 in 2026-2027; \$979,046 in 2027-2028; \$1,008,417 in 2028-2029 and \$1,038,670 in 2029-2030 for a total of \$4,899,509 over a five (5) year period.

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of estimate and may reflect the impact of early payment discounts, compression and the collection rate.

Mohawk Valley Rural Fire District

Measure No: 20-353

Caption: Five-year operating levy for fire and emergency medical services.

- Question: Should Mohawk Valley RFPD issue a local operating levy for fire and emergency services for five years beginning in 2024-25? This measure may cause property taxes to increase more than three percent.
- Summary: The measure, if approved, would authorize the district to levy taxes to support the annual cost of fire and emergency medical services including an additional two new employees, and the establishment of a student recruitment and training program, while expanding 24/7 coverage within the District. The measure would provide for a local option operating levy at a rate not to exceed \$0.60 cents per \$1,000 of taxable assessed value within the district for five years, beginning July 1, 2024. The estimated revenue over five years is:

#### Proposed Row River RFPD

Measure No: 20-350

Caption: Row River Rural Fire Protection District Formation with permanent tax.

- Question: Shall Row River Rural Fire Protection District form with a permanent tax rate of \$2.40/\$1,000 assessed value beginning FY 2024/2025?
- Summary: The Row River Valley, identified as high fire risk, is without Fire and EMS services. Advocates argue there is a need for essential services in this area and are proposing formation of this district to meet said need. The District shall include all unprotected properties north of Dorena Lake beginning near milepost 6.5 of Row River Road, east to the intersection of Brice Creek Road/Layng Creek Road. Then continuing east to milepost 1.5 of Brice Creek Road, and to 40400 Layng Creek Road more or less. And south of Dorena Lake beginning at milepost 2 of Shoreview Drive, east to the intersection of Row River Road, including properties on roads accessed from Shoreview Drive and Row River Road. Formation would occur June 30<sup>th</sup>, 2024.

Formation of the Row River Rural Fire Protection District with a permanent tax rate of \$2.40 per \$1,000 of assessed value will allow for the new district to serve a currently unserved area with emergency medical and fire protection services. At this election, the proposed district's board shall be voted on.
