### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

The overall goal of AFFEC’s Host Home Program is to provide local youth and young adults (YYA) experiencing HOIH with a safe space to live apart from families. In general, these are short-term placements (less than six months) that provide YYAs to remain stabilized, allowing them to focus on their health and education. In addition to housing, participants are provided case management, connection to needed resources and mentorship, as well as enrichment opportunities.

Currently, AFFEC is the that operates a Host Home Program in our area. AFFEC recruits, assesses, onboards and supports current host homes in Lane County. Host Home Program by using vetted community member’s homes as either short-term (less than six months) or long-term (more than six months) housing for unaccompanied HIOH youth under the age of 25. YYA are identified through the front door assessment and referred to the subrecipient upon request. The subrecipeint participates in Lane County led, bi-weekly, case conferencing calls with other YHDP projects to ensure that referred YYA are met using warm-hand offs.

This project has also created its own youth advisory council (YAC) that meets on a quarterly basis. The YAC discusses and provides input on program design and implementation. The chair position is also a voting-member of the subrecipient's Board of Directors.

**1a. Provide a description that addresses how this project will follow Positive Youth Development.**

All AFFEC staff and host home providers participate in Positive Youth Development training. All new youth work professionals, volunteers, and advocates are introduced to this 'intentional, prosocial approach that engages youth within their communities, schools, organizations, peer groups, and families in a manner that is productive and constructive; recognizes, utilizes, and enhances young people's strengths; and promotes positive outcomes for young people by providing opportunities, fostering positive relationships, and furnishing the support needed to build on their leadership strengths." As an organization that serves YYAs, we strategize ways to put these principles into action. The Developmental Assets® framework, created by Search Institute, contributed to Positive Youth Development theory and practice. Developmental Assets® are positive factors within young people, families, communities, schools, and other settings that research has found to be important in promoting the healthy development of young people. AFFEC has long used this framework in its Mentor Program and to inform our other youth development programs. Emphasizing program participants' strengths (e.g., strength-based coaching questionnaires and assessment tools include strength-based measures, case plans include assessments of program participants' strengths and focus on goals and aspirations) in intake interviews and ISPs for Host Home Program participants. Previously, most youth development research focused on "risk factors" or negative outcomes, such as teen pregnancy or substance use. AFFEC was founded on increasing positive outcomes for YYAs. The program supports competence (academic, social, and vocational), self-confidence; connectedness (healthy relationships to family, friends, and community), character (integrity, moral commitment), and caring and compassion. We ensure YYAs are given a voice and are viewed as equal partners in developing their ISP using a trauma-informed approach.

**1b. Provide a description that addresses how this project will follow Trauma Informed Care.**

When establishing a trauma-informed Host Home system, we apply the following five principals:

- (1) Awareness of the effects of trauma on youth and young adults.
- (2) Safety for YYAs on a physical and emotional level.
- (3) Trustworthiness in processes and relationships.
- (4) Empowerment in decision-making processes; and
- (5) Inclusiveness for all, including individuals from marginalized groups and people with disabilities.

Prioritizing program participant choice is essential as to not to re-traumatize youth or young adult exploring or entering the Host Home Program. The entire Host Home selection process is youth-choice and client driven. AFFEC staff carefully listen to youth or young adult' stated preferences and needs. Only if, and when, the YYA feels comfortable proceeding with a visit or placement does the discussion and process continue. If the YYA doesn't feel comfortable or has other concerns, the Host Home Program staff will share details of other homes that are available. While house rules are created, and Individual Service Plans agreed upon, YYA participants have recourse after placement.

**1c. How does this project help the community meet the shared vision, goals and objectives of the coordinated community plan?**

Lane County envisions a community where our response to youth and young adult (YYA) housing instability or homelessness (HIOH) will be swift and accessible. All youth in our community will be aware of available services before housing instability occurs, and will have the support they need to successfully complete a K-12 education and post-secondary training so they may obtain employment that, at a minimum, provides a living wage and the foundation for the advancement of their choosing. Educators, community members and stakeholders will be coordinated and accessible, and will have a thorough understanding of the resources available for any specific youth in need before a housing crisis occurs.

Understanding that no two YYA experiencing HIOH are the same, our programs are individualized and inclusive of particularly at-risk populations including:

- \*Pregnant and parenting youth
- \*Youth involved in the criminal justice system
- \*Youth aging out of the foster care system
- \*Youth experiencing physical and mental health challenges
- \*Youth with different abilities including intellectual and developmental
- \*Survivors of human trafficking and exploitation
- \*Black, Indigenous and People of Color (BIPOC)
- \*LGBTQIA+ youth
- \*Immigrant youth
- \*Linguistically diverse youth
- \*Youth living in rural communities
- \*Youth from different socioeconomic backgrounds
- \*And minors under the age of 18

A Family for Every Child's vision incorporates a variety of services to address YYA HIOH and includes expanding the definition of homelessness so that resources are available for youth who are couch surfing, doubled up, attempting to leave domestic violence situations, or at imminent risk of homelessness. All youth that utilize our resources are treated equitably and with dignity and respect. We envision a community where all programs will be strengths-based, trauma informed and come from a place where positive youth development is at the forefront of community partners' agendas.

The subrecipient prioritizes providing participants with programming that is person centered and is participant driven. This begins with ensuring that minority groups feel comfortable and safe entering into programming. AFFEC prioritizes hiring staff with lived experience. They also are committed to gathering and incorporating youth voice into programming through asking the YAC for guidance and insight into their efforts. The YHDP YAC includes voices with lived experience.

A Family for Every Child used data provided through the local HMIS, Youth Point-in-Time count data, Oregon Department of Education annual numbers (McKinney Vento and School Districts demographics to analyze the local population. According to the US Census website, as reported on July 1, 2022, Lane County is home to 88.6% White alone with Hispanic or Latino is 10.1%. AFFEC conducts outreach to culturally responsive agencies and local school districts to educate both staff and populations served about host homes.

**5b. Identify any potential barriers to persons or communities of color equitably benefiting from your proposed grant activities.**

Youth and young adults in Lane County have been hesitant to engage in conversations around accessing a host home as they are worried that choosing a host home means they are entering into foster care. The subrecipient acknowledges the similarities between foster care and host homes -living in a stranger's home in both cases- and how that acts as a barrier to accepting the referral. The subrecipient has focused on educating youth and young adults, and other agencies, on the youth-choice focus of their project. YYA and a potential host home meet, more than once in some cases to ensure that it is a good "fit" for all involved.

**5c. Detail the steps you will take to prevent, reduce or eliminate these barriers.**

As mentioned in 5c. AFFEC provides program information through community events, tabling, talking at staff meetings and engaging other youth advisory councils on how their project operates. They have implemented "Meet and Greet's" between YYA and the potential host home to ensure compatibility. They also focus and prioritize on recruiting host homes that represent communities of color to ensure that they eliminate barriers

The project participates in continuous quality improvement on a quarterly basis to track their efforts. They use data to inform their annual strategic plans and plan out their efforts for the next year. This informs the projects program and project implementation.

The agency is connected to the agency 15th Night who brings together service providers from social services, employment programs, education and homeless youth programs. The agency had close relationships with those services providers to ensure that participants are able to access services and benefits quickly through the removal of barriers to accessing those programs. The project works with collaborating partners, our YHDP workgroup, youth and young adults case conferencing meetings, McKinney Vento and through the Rapid Access Network to engage with those entities. When they meet with a YYA referred to the program they quickly do a support structure assessment and get the necessary releases of information signed so they can begin to connect to partners.

The subrecipient has facilitated host home recruitment sessions for the community to engage curious community members around becoming a host home. They table at resource fairs, have revamped their website <https://www.afamilyforeverychild.org/>, produced a local commercial, presented to volunteer organizations and send out a monthly newsletter. The subrecipient has a Host Home Coordinator who focuses on the efforts to identify, recruit, and onboard host homes.

**2b. How will this project match youth with hosts?**

The subrecipient has created "Host Home" provider books for each host home they have certified. Once the YYA accepts the referral the case manager presents any and all available host home provider books to the YYA to look through. Once the YYA identifies a home then the a "Meet and Greet" meeting is arranged for the YYA and the home to meet. They may choose to meet several times including a tour of the home. The case manager works closely with the YYA to ensure that they are comfortable with their selection.

**2c. What services will be provided to ensure the host home is successful?**

The project has a dedicated Host Home Coordinator who provides ongoing support and training to the host home. The coordinator works closely with the case manager and YYA to assess needs, challenges and successes of the host home arrangement. They provide space at the beginning of the living situation to establish house rules and help the parties navigating any changes that need to be made as the relationship between host home provider and YYA develops and grows.

**2d. At project capacity, how many youths will be in host homes?**

The project intends to serve 17 youth and young adults in a host home per grant year.

## VAWA Budget

- Utilities. Grant funds can be used to pay for costs of establishing utility assistance in the safe unit the survivor is transferring to.
- Housing Fees. Grant funds can be used to pay fees associated with getting survivors into a safe unit via emergency transfer(s), including but not limited to application fees, broker fees, holding fees, trash fees, pet fees where the person believes they need their pet to be safe, etc.
- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).
- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.

B. VAWA Confidentiality Requirements. Examples of eligible costs for ensuring compliance with VAWA confidentiality requirements include:

- Monitoring and evaluating compliance.
- Developing and implementing strategies for corrective actions and remedies to ensure compliance.
- Program evaluation of confidentiality policies, practices, and procedures.

- Reporting to CoC Collaborative Applicant, HUD, and other interested parties on compliance with VAWA confidentiality requirements.
