Permit Conditions of Approval

Vendor Initials

- 1 _____ Vendor must have and provide, or obtain within 30 days of approval of this permit, a copy of their license from the Lane County Environmental Health Department permitting Mobile Food Unit sales. This license must be visible to the public at all times while conducting concession services at any Lane County Park.
- 2 _____ All concessionaires must have and provide a copy of their current Food Handlers Permit.
- 3 _____ Vendor must conduct all sales in designated concession space and areas according to maps associated with this permit.
- 4 _____ Designated concession space is limited and open on a first-come-first-served basis. This permit does not guarantee available space, but rather, permits the sale of goods in available designated concession space and areas.
- 5 _____ Vendor must provide a monthly sales and information report as requested by Lane County Parks.

- 6 _____ Overnight storage of vendor's concession station is not permitted, unless otherwise approved below. Overnight storage is at the sole risk of vendor. There is no expectation of security.
- 7 _____ Use of amplified equipment is permitted between 10:00 am and 8:00 pm
- 8 _____ Sale of Beer, Wine, or Liquor is NOT PERMITTED. Failure to comply with this rule will result in immediate void of permit. THIS IS A ZERO TOLERANCE POLICY.
- 9 _____ No weapons of any kind may be stored in your concession area or on your person while inside a Lane County park, even if you are a carrier of a concealed weapons permit. NO EXCEPTIONS.
- 10 _____ Regardless of items being sold, all concession stations must be equipped with a first-aid kit and a minimum 10 lbs ABC rated fire extinguisher.
- 11 _____ Vendor must provide a Certificate of Insurance in the amount of \$500,000 of Commercial General Liability and an Additional Insured Endorsement with the following language: Permit holder agrees to indemnify, defend, and hold Lane County, their Commissioners, agents, officers, and employees harmless from and against all claims, suits, actions, losses, damages, liabilities, costs and expenses of any nature resulting from, arising out of the activities of, or failure to perform by permit holder or its officers, employees, subcontractors, or agents under this permit.

I, the undersigned, hereby save, indemnify, and hold harmless Lane County and the U.S. Government from any liability or damages incurred by myself or any third party while performing the services of this permit. I also understand that permission to use park facilities carries with it the duty to reimburse the County for any damage to County real or personal property. I also agree to comply with the Lane County Parks Rules, and to the conditions of approval listed above.
