Disabled Services Advisory Council, March 11, 2005

- 1. On the draft maps shown at the meeting, there are no indications of disabled access. Does that mean there aren't any?
- 2. When Lane Independent Living Alliance (LILA) was formed about 3 years ago, LILA was invited to participate in revamping and upgrading Alton Baker Park. Take a look at the City of Eugene draft Parks Plan. Collaborate with other agencies during the planning process and during physical park development.
- 3. Worked in the past on the Florence Parks Advisory Committee. It was very frustrating because it got our hopes up and there items are often left unfunded.
- 4. Look at the City of Eugene Parks draft summary of funding sources.
- 5. Is there a way to tap into federal funding, Northwest Youth Corps, and vocational training? They contract for year round maintenance of parks.
- 6. Make sure funds are dedicated so they cannot be taken away.

Friends of Buford Park, March 16, 2006

- 1. How does funding vary by County for County Parks?

Mt. Pisgah Arboretum, March 21, 2005

- 1. Has the County lost park lands since 1980? Lane County Parks system used to be the biggest in the nation.
- 2. A levy which we helped campaign to get passed about 5 years ago was turned down. Is that being reconsidered?
- 3. Is acquisition being considered?
- 4. How is Mt. Pisgah being addressed in the Master Plan update?
- 5. Will the plan address funding for Camp Lane and other parks?
- 6. Have you considered going after room taxes?
- 7. Parks were defunded in the 1980's. State law was changed so the gas tax could no longer be used for anything but roads; this has significantly decreased parks' budgets and other publicly funded items.
- 8. Other parks should have a volunteer organization like Mt. Pisgah.

Native Plant Society, March 22, 2005

- 1. Did Big River Park used to belong to the BLM? Once it was going to be logged and then, was it transferred, about 1987 or so?
- 2. Is Blue Mountain Park logged? Concerned about the precedent this sets.
- 3. What are the staffing levels at LC Parks, and is there a planner?
- 4. What is the focus of maintenance staff?
- 5. Native Plant Society is 26 years old. Write letters and go to the state on a regular basis. Was active in Integrated Management Plan effort at the County.
- 6. Surveyed County Roads and plants. Would be interested in doing more plant surveys, and could do field trips for staff. The County could help identify these sites. Some have already been surveyed Kinney Park, for instance.
- 7. Maintenance activities can harm sensitive plants. Native Plant Society would be interested in providing education about plants to Parks staff. Could do a slide presentation and training. We've found that training makes a big

- difference and Road Maintenance/Vegetation Management staff were interested in the information. Once they have the information they like to use it.
- 8. How will Parks provide for developed and undeveloped uses?
- 9. Keep in mind that campgrounds don't need to be provided everywhere just to serve the public on a few days a year, like July 4th and other holidays.
- 10. What is envisioned for the Horse Arena Park at HBRA?
- 11. Native Plant Society would be interested in working along side the County when areas are developed for park uses, like campgrounds.
- 12. More access to parks by bike trails is needed. A bike trail between Mt. Pisgah, LCC and other green/open space areas would be great.
- 13. What's being done with BRING?
- 14. There are federally listed plants in HBRA.

- 23. Siuslaw Falls Park needs work –signage, maintenance, trash receptacle, bathrooms. It's a great park.
- 24. Lane County doesn't show interest in working in partnership and accepting stewardship money.

POTENTIAL PRIORITIES FOR THE COUNTY PARKS PLAN

- HBRA to the confluence
- Armitage Park and adjacent land
- Quamash Prairie
- Short Mountain (the mountain itself)
- Interface between Metro City Park Plans and County Park Plan path connections, identify key parks, TransPlan, promote continuity and consistency between the plans
- Clearwater to Pisgah
- Middle Fork Trail a good opportunity for overlap between plans
- McKenzie River Blueway this is supported in TransPlan
- Support McKenzie/Green Island confluence area
- Mt. Pisgah Ridgeline River; I-5 Franklin; consider transportation & development issues
- West Eugene Wetlands/Fern Ridge potential County lead
- River-related recreation opportunities. Look at Albany-Corvallis and Salem areas and what they're doing. Talk with Philip Richards for more info.
- Bike touring/wine country bike facilities.
- Agricultural tourism how might this relate to Parks Plan? Tour routes?
- Potential partnership on Santa Clara Park camping –
- Note Willamette Bikeway Champoegh to Armitage
- Emphasize and continue integration between plans of agencies; County plays an important role in brokering with federal and state agencies.
- Stay in the Regional Parks business seek opportunities while also providing rural areas with neighborhood parks.
- Maintain focus on funding emphasis federal and state funds
- Encourage looking for opportunities to consolidate such as boat landings in Metro area exchange to other agencies.
- Look at parks that are out in the middle of nowhere and consider whether it would make sense to exchange or transfer them to other agencies to have them in public ownership
- There is support for efforts to sell certain properties to leverage money
- Which sites or parks are profitable, if any?
- Grant funding collaborate with cities if possible on applications. Private non-profit grants, as well as federal/state grants.
- Archery facility?
- Emphasize connections The Nature Conservancy has identified areas they think are worthwhile.
- English-model trails that run along property lines might be considered.
- Agricultural uses/buffers function as trail connections.
- There is an old landfill by 52nd Street in Eugene is this an opportunity?
- Emphasize the Middle Fork Trail
- Deadmond Ferry Landing potential transfer of ownership and expansion of recreational facilities there river access
- Armitage Park Pathway connection to River Bend/Deadmond Ferry
- Articulate focus compared to City Plans
- Middle Fork has been discussed it's the north bank that is of most interest; but also consider the south bank/Franklin-Eugene Connection.
- Avoid duplication

- Aggressively pursue regional trail and funding as illustrated in Rivers to Ridges
- Southern Pacific Railroad Brownsville line: Gateway area to Armitage Park and beyond. Abandoned railroad line. Look at Coburg Parks Plan.
- Consider recreational opportunities that are more appropriate for County Parks versus City parks –archery, mountain biking/"free-riding", and courses –the "Lane County X Games", Frisbee golf, equestrian activities.
- Encourage leveraging/partnering CVALCO, Lane County Farm Bureau, The Nature Conservancy, McKenzie Trust (look at Green Island), Trust for Public Land, American Farmland Trust.; look at Galeda near Santa Barbara it's sort of a teaching farm; Food for Lane County.
- Visionary aspect what is the Vision, Scope, Level of Service, given current resources, look at the practical aspect and how to tie into the Vision. Hope document looks at alternative revenues analysis.
- Rivers to Ridges is based upon natural resources; can be transparent in fringe (boundary) areas support
 park/recreation/natural resource actions without necessarily assigning responsibility leave flexibility/options for
 working with others and supporting other agencies to carry out vision. Same for recreational facilities. Others
 besides Lane County could participate in operations.
- Fern Ridge see City Parks Plan and TransPlan make a link to Fern Ridge. City can help with funding; need help with working with property owners and with alignment County involvement could leverage support and funding. Look at a specific destination at Fern Ridge for the connection.
- City of Veneta wants to connect with City of Eugene path mix in Fern Ridge.
- Funding is needed to develop the actual Fern Ridge Bike Path connection Plan –provide support for this in the County Parks Master Plan.
- Spencer Creek a drainage basin and blueway; would the County be interested in partnering; for example, the City could facilitate the purchase while County could own or partially own.
- Natural resource component: several bioregional studies have been done oak woodlands, and savannah studies, for instance. Help preserve these resources, possibly by using county lands for sustainable harvest while preserving habitat. Like Beazell Memorial Forest in Benton County.
- Plan coordination with and support projects from Eugene Waterways Study check with Stephanie Schulz or Ollie Snowden.
- Support interpretation /education facilities, and work with partners on things like the West Eugene Wetlands Education Center. Provide a letter of support, for instance. It is a tourism draw.
- Grant writing add a full time staff person to go after funding.
- Proposed natural heritage study coordinate with regional partnership to look at Cascades to Coast National Park Service Study currently looking funding for this. Talk with Comm. Green, CVALCO.
- Include a policy statement to preserve vistas, like at the urban fringe, Coburg Hills; possibly assist in acquiring/managing not only for the Metro area, but other urban areas, like Cottage Grove.
- Note that municipalities are heavily impacted by the County Parks plan and actions outside their jurisdictional boundaries.
- Include language regarding partnering with federal/state/other agencies.
- South Thurston Hills, Jasper-Natron area.
