4-2. Describe how the CoC determined that this project should be reduced and include the date the project applicant was notified of the reduction. (limit 750 characters)

The applicant contacted the Continuum of Care lead (Lane County) to alert the CoC of a potential significant balance remaining for the current grant year. This project had a significant balance in previous years as well. After several conversations, the applicant determined the best course of action would be to voluntarily reallocate a portion of this project as the funding balance was projected to continue in future grant periods, despite efforts to serve additional households and bring on an additional service provider to provide more services. The applicant confirmed the amount to reallocate on 10/4/21 and the CoC confirmed the reallocation in writing on 10/4/21. The reallocation was reviewed and approved by the REH Committee of the CoC Board on 10/8/21.

Fiscal Year 2021 Grant Application Projects
HUD Continuum of Care Program**

The projects summarized below are included in the FY2021 HUD Continuum of Care grant application. They provide critical services for families and individuals experiencing homelessness to address housing and services gaps in Lane County.

The **Lane County Continuum of Care Grant** renewal and new projects include:

1. Camas Permanent Housing Project

Camas Permanent Housing Project serves 12 households without children and 2 households with children where there is a history of chronic homelessness and a diagnosis of serious mental illness or a pattern of acute medical care needs. They will reside in scattered site permanent supported affordable housing through a housing first approach. Participants are provided permanent housing in the Eugene/Springfield/Lane County area. Households receive intensive case management to help clients obtain the skills and income needed for self-sufficiency, self-determination and housing stability. *Camas Permanent Housing Project will serve up to 14 households with adults only and two households with children at any given point in time.*

2. Cascades Rapid Rehousing Project

Cascades is a rapid rehousing program which will provide rapid rehousing services to single adults who are homeless. Eligible singles will receive case management services to stabilize their housing situation. Case managers identify and build their plan of action with participants including increasing education and training, obtaining more gainful employment, building positive relationships with landlords and neighbors, building savings, building communication skills and accessing community resources. *Cascades will serve 9 households with adults only at any given point in time.*

3. Emerald Options

Emerald Options is a permanent housing project providing long-term, community based housing and supportive services to homeless persons with developmental disabilities including disabled individuals and families. *Emerald Options serves 10 households with adults only and 5 households with children at any given point in time.*

4. OR-500 CoC Planning Application 2021

Lane County Human Services Division is responsible for the administration of Continuum of Care (CoC) planning grant. The CoC is responsible for developing a plan that coordinates housing and service system that meets the needs of homeless individuals and families within its geographic area. The plan must be developed using a comprehensive community-based or region-based approach to ending homelessness. The CoC's plan addresses the specific needs of all homeless subpopulations, including, but not limited to persons with substance abuse issues; persons with HIV/AIDS; veterans and their families; the chronically homeless; families with children; unaccompanied youth; persons with serious mental illness; and victims of domestic violence, sexual assault, and stalking.

5. LANE HMIS

Lane County Human Services Division is responsible for the overall administration of LANE Homeless Management Information System (LANE HMIS) project. Lane County Continuum of Care previously participated in the State of Oregon's HMIS from April 2005 until 2019, when it began participating in its own implementation of HMIS. The LANE HMIS uses Wellsky Community Services HMIS data for budgetary decision-making, grant applications, program performance measurement, and to illustrate the conditions of poverty in Lane County. Lane County Human Services Division provides agency-level HMIS reports to participating HMIS agencies for similar uses.

6. McKenzie Rapid Rehousing Project

McKenzie Rapid Rehousing is a rapid rehousing project which facilitates the movement of homeless individuals and families to permanent housing. McKenzie serves individuals, families, and youth (under 25) households experiencing homelessness. Households receive financial assistance, along with case management and supportive services, in order to achieve stability in permanent housing. *McKenzie Rapid Rehousing serves 9 households with adults only and 33 households with children at any given point in time.*

7. Shankle/MLK

Shankle is a permanent housing project that serves chronically homeless persons with a severe and persistent mental illness through 11 scattered site units in the community. Individuals successfully stabilize in permanent housing by getting assistance with mental health recovery and connections to the supports they need to create resiliency, self-sufficiency and stability. MLK is a 51 unit site-based permanent supportive housing project that prioritizes individuals who are also identified as frequent users of health care, emergency medical, human services and public safety systems (FUSE). They may present with one or more of the following disabilities: a serious mental illness, physical disability or chronic health condition, developmental disabilities, substance abuse issues or HIV/AIDS. MLK offers a permanent housing subsidy through project-based vouchers, along with supportive services including connections to behavioral health, healthcare services, substance use services, and case management. *Shankle serves 11 households with adults only at any given point in time; MLK serves 51 households at any given point in time.*

8. Sahalie Permanent Housing Project

Sahalie Permanent Housing Project provides services to chronically homeless individuals. Individuals are also identified as frequent users of health care, emergency medical, human services and public safety systems. They may present with one or more of the following disabilities: a serious mental illness, physical disability or chronic health condition, developmental disabilities, substance abuse issues or HIV/AIDS. Housing is subsidized and supported with a program of intensive case management known as Frequent Users System_Engagement (FUSE). Case managers assist with coordination, skill building and emotional support, housing retention and help to build social support systems. Individuals are linked to individualized supportive services, to help them obtain housing stability and avoid returns to costly crisis services and institutions. Program participants reside in scattered site permanent housing units through a housing first approach. *Sahalie Permanent Housing Project will serve up to 13 households with*

adults only at any given point in time.

9. Sunstone Rapid Re-housing Project

Sunstone Rapid Re-housing Project is a rapid rehousing project which facilitates the movement of homeless individuals and families to permanent housing. Sunstone serves households who are victims of, fleeing or attempting to flee, domestic violence, sexual assault or stalking and experiencing homelessness. Households receive financial assistance, along with safety planning, case management and supportive services, in order to achieve safety and stability in permanent housing. *Sunstone RRH will serve up to 8 households at any given time.*

10. The Nel PSH Project

The Nel is a 45 unit site-based permanent supportive housing project that prioritizes individuals who are chronically homeless. Individuals may present with one or more of the following disabilities: a serious mental illness, physical disability or chronic health condition, developmental disabilities, substance abuse issues or HIV/AIDS. The Nel offers a permanent housing subsidy through project-based vouchers, along with supportive services including connections to behavioral health, healthcare services, substance use services, and case management. *The Nel will serve up to 45 households at any given time.*

The **St. Vincent de Paul (SVDP)** Continuum of Care grant renewal projects include:

11. Connections

Connections provides rapid re-housing for homeless families with children. Scattered site housing is offered throughout Eugene and Springfield. Households receive financial assistance, along with case management and supportive services, in order to achieve stability in permanent housing. *Connections serves 21 households with children at any given point in time.*

12. LIFT (Living Independently Following Treatment)

LIFT is an inter-agency collaborative project designed to fill an unmet need for services to promote self-sufficiency of chronically homeless individuals and families with co-occurring mental illness and addictions. Participants are provided permanent housing in St. Vincent de Paul-owned affordable housing complexes in the Eugene/Springfield area. Households receive housing, education, and intensive case management to help clients obtain the skills and income needed for self-sufficiency, self-determination and housing stability. *LIFT serves 8 households with adults only and 10 households with children at any given point in time.*

13. Vet LIFT

The Vet LIFT is a permanent housing project serving chronically homeless veterans with dual diagnoses of a mental disorder with substance abuse. The project addresses the need for permanent housing for homeless individuals with disabilities and their need of skills and resources to obtain and maintain self-sufficiency. Participants are housed in single bedroom apartments and receive an array of supportive services to address the multiple barriers to stability. *Vet LIFT serves 18 households with adults only at any given point in time.*

The **Homes for Good** Continuum of Care grant renewal projects include:

14. SPC/Madrone Consolidated Project

The Homes for Good consolidated Shelter Plus Care (S+C)/ Madrone tenant-based rental assistance program provides housing to families and chronically homeless individuals with disabilities. The majority of the participants have co-occurring mental health and substance abuse issues. Other target populations served include Veterans, people living with HIV/AIDS, chronic health conditions, developmental disabilities and those experiencing or fleeing domestic violence. *SPC/Madrone Permanent Housing Project serves a total of 73 households.*

FY2021 Continuum of Care (CoC) Program Competition

Ranking and Priority Listing Process

HUD Continuum of Care NOFA and Priority Listing

Each year, the Department of Housing and Urban Development (HUD) releases a Notice of Funding Opportunity (NOFO) for the Continuum of Care (CoC) Program.

Continuums of Care apply for funds through a Collaborative Application, rather than individual projects applying for funds. As part of this collaborative application, HUD requires that CoCs rank their projects in two tiers, in the event that enough funding is not available to fund all new and renewal (existing) projects.

Summary of Guidance from FY21 NOFO:

- CoCs will be required to rank all projects, except CoC Planning, including renewal projects and new projects submitted through reallocation or bonus.
- HUD will continue the Tier 1 and Tier 2 funding process. HUD establishes each CoC's Tier 1 and Tier 2 amounts based on the total amount of funds requested by eligible renewal projects, combined with the eligible renewal project amounts reallocated during the competition.
- Tier 1 is equal to 100% of the CoC's Annual Renewal Demand (ARD) (\$3,935,094) minus the Annual Renewal Amounts (ARAs) of YHDP renewal and YHDP replacement projects (\$0, n/a).
- Tier 2 is the difference between Tier 1 and the maximum amount of renewal, reallocation, and CoC Bonus funds that a CoC can apply for, but does not include YHDP renewal or replacement projects, CoC Planning, or projects selected with DV Bonus funds.
- Projects placed in Tier 2 will be assessed for project eligibility and project quality threshold requirements, and if applicable, project renewal threshold requirements, and funding will be determined using the CoC Application score as well as factors listed in the NOFO.
- If a project straddles Tier 1 and Tier 2 funding line, HUD will conditionally select the project up to the amount of funding falling into Tier 1 and will then score the remainder falling into Tier 2. If HUD does not fund the Tier 2 portion of the project, HUD may award the project at the reduced amount, provided the project is still feasible with reduced funding.
- For new projects the CoC indicates it would like considered as part of the DV Bonus, HUD will award a point value to each project application combining both CoC Application score and responses to the DV bonus specific questions in the CoC application. If a DV Bonus project is conditionally selected, HUD will remove it from the listing and all others ranked below will slide up the ranking. If the DV bonus project is not selected with DV Bonus Funds, the application will remain in its position and will be considered for bonus project funding.

New Projects

CoCs may submit new projects created through reallocation, bonus, a combination of reallocation and bonus, or new DV Bonus projects. The following types of projects may be created under these categories:

The FY21 NOFO includes both FY20 and FY21 HUD Appropriations Act provisions of up to \$102 million for Domestic Violence Bonus projects. CoCs will be able to apply for DV Bonus for PH-RRH, or Joint TH-RRH projects, along with SSO for Coordinated Entry specific to Domestic Violence.

Reallocation

On October 4th, Homes for Good notified Lane County, CoC Lead, of intent to voluntarily reallocate \$232,381 from the SPC/Madrone Consolidated project to the CoC to be used for New projects. Lane County sent written notification to Homes for Good confirming this reallocation on October 4th.

The reallocation was accepted by the RFP-Eval-HMIS Committee on October 8th, 2021. The committee approved allocating this available funding to the Nel PSH project being submitted for Bonus funding.

Bonus

Up to 5% of the Final Pro Rata Need (FPRN), or \$196,755, is available for new Bonus project(s). The RFP-Eval-HMIS Committee approved submission of the Nel (1100 Charnelton) Project for the Bonus funding available. Reallocated funding will be added to the Bonus amount available for a total of \$429,136.

DV Bonus

With approval from the RFP-Eval-HMIS Committee, Lane County released a Request for Proposals (RFP) to seek a subrecipient for a Joint TH-RRH or RRH DV Bonus project to specifically serve victims of domestic violence, dating violence, or stalking with dedicated units and/or services. One proposal was received. After panel review, this project was recommended to the RFP-Eval-HMIS Committee for submission. The committee approved submission of this project for the DV Bonus Opportunity.

Ranking Scenario

In completing the CoC Final Ranking, the RFP-Eval-HMIS committee reviewed the results of the Evaluation, guidance from HUD from the FY21 NOFO, as well as several different scenarios for ranking. All projects were reviewed based on an average of three years' of Evaluation scores and performance outcomes, which include placement in and exits to permanent housing, income growth, HMIS data quality, and populations served (priority, highly vulnerable, etc.). The following ranking scenario was approved by the committee and the PHB for FY21:
