NOTICE OF LANE COUNTY PLANNING COMMISSION PUBLIC HEARING

Notice is hereby given that the Lane County Planning Commission will conduct a Work Session and Public Hearing on <u>Tuesday, July 19, 2022</u>, on File No. 509-PA22-05378. The work session will begin at 6:00 PM and the public hearing will begin at 7:00 PM.

The meeting will be held in **a hybrid format, with in-person and remote call-in options** (see below for call in information). The in-person meeting will be held at the Lane County Customer Service Center, Goodpasture Room, 3050 North Delta Highway, Eugene, Oregon 97408. The Planning Commission will consider the following proposal:

PROPOSAL: Department File No. 509-PA22-05378 / Amendments to Lane Code (LC) 16.290 to incorporate an allowance for accessory dwelling units (ADU) in rural residential zones as allowed by Senate Bill 391 and ORS 215.495, and an allowance for conversion of a historic dwelling to an ADU as allowed by House Bill 3012 and ORS 215.501.

The proposed Lane Code amendments will be available for inspection on Tuesday June 28, 2022, online and at the Lane County Customer Service Center, 3050 N Delta Hwy., Eugene, OR 97408. - a. Announcement of the nature and purpose of the hearing
- b. Announcement of opportunities for submission of information and appeal.
- c. Disclosure of ex parte contacts
- d. Abstentions
- e. Report by staff
- f. Public Testimony
- g. Any additional comments by staff
- h. Conclude the hearing

Failure of an issue to be raised in a hearing in person or by writing, or failure to provide sufficient specificity to afford the Approval Authority who conducts the hearing an opportunity to respond to the issue precludes appeal to the Land Use Board of Appeals on that issue.

The application, all documents and evidence relied upon by the applicant (Lane County), and the applicable criteria are available for inspection at no cost at the Land Management Division or online.

Following Planning Commission action, the recommendation and proposed amendments will be considered for adoption by the Lane County Board of County Commissioners.
